You further waive any and all rights to review or approve any use of the images taken by Shannon Martin Photo for any purpose as agreed to in this Release.

You agree that no images may be made available by You to any third party. Any use of images provided to You by Shannon Martin Photo will only be for personal use, unless made by agreement with Shannon Martin Photo. Non-personal use of any images of which have not been approved will be billed to you at up to CAD \$6000 per image per use. No watermark or logo may be removed, tampered with or cropped by You or any third party. Images with no watermark or logo may be provided to You at the discretion of Shannon Martin Photo. This agreement shall not obligate Shannon Martin Photo to use the images or to use any of the rights granted hereunder, or to prepare, produce, exhibit, distribute or exploit the images.
